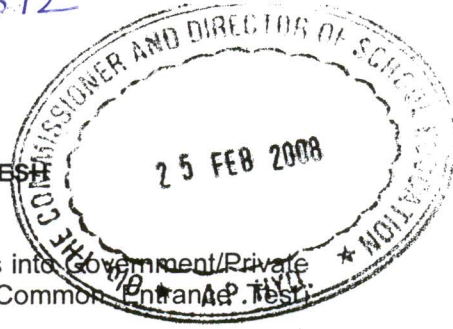

ORDER :

In the reference read above, the Director of School Education, A.P. Hyderabad has submitted proposals and requested the Government issue suitable orders to permit the Private un-aided non-minority and minority Pandit Training Colleges to fill up Category-B (20% of the sanctioned intake) seats with all eligible candidates who passed the N Be qualifying examination only without LPCET as was considered in respect of Private B.Ed and D.Ed Colleges.

2. Government after careful examination of the proposal of the Director of School Education, A.P. Hyderabad hereby accept the proposal and issue the following notification which shall be published in the extraordinary Gazette of Andhra Pradesh.

NOTIFICATION

In exercise of the powers conferred by sections 3 and 15 of the Andhra Pradesh Educational Institutions (Regulation of Admissions and Prohibition of Capitation Fee) Act, 1983 (Andhra Pradesh Act 5 of 1983), the Governor of Andhra Pradesh hereby make the following amendment to G.O.Ms.No.29, Education (SE-Trg-1) Department, Dated: 29-3-2007.

AMENDMENT

In rule 3, sub-rule (ii) (c) shall be substituted as follows:

"(c) The Category B Seats shall be 20% of the total sanctioned intake of seats in pandit training course in respect of the Un-Aided Non-Minority and Minority Pandit Training Colleges, which shall be open for admission to all the eligible candidates who satisfied the eligibility criteria for admission laid down in rule 4 (iii) of G.O.Ms.No.29, Education (SE-Trg-1) Department, dt.29-3-2007 without insisting LPCET"

In rule 4, sub-rule (iii) the words "Candidates should have obtained a rank either in LPCET/LPCET-AC conducted for the academic year concerned and should satisfy the eligibility qualifications prescribed as below for each Pandit Training course" shall be substituted with the words "Candidates under Category A seats should have obtained a rank either in LPCET/LPCET-AC conducted for the academic year concerned. The candidates should satisfy the eligibility qualifications prescribed as below for each Pandit Training course"

In rule 5, sub-rule (i) shall be substituted as follows:

"(i) The admissions for Category A seats shall be made in the order of merit on the basis of the rank assigned in the LPCET/LPCET-AC"

In rule 5, sub-rule (iv) the words "Private-Aided/Private Un-aided pandit training colleges" shall be substituted with the words "Private-Aided(Category A)/Private Un-aided (Category A) pandit training colleges"
